- List of cast & crew members and local vendors
- Location maps showing specific streets, buildings, etc.

**PLEASE NOTE:**

It is the responsibility of the production company to notify all business and residential tenants who will be affected by filming. Permission to use private property must be granted in writing by property owners/landlords/property management companies before filming begins and copies of these letters filed with Eagle Mountain City.

All structures constructed by the Production Company must be completely dismantled and the site returned to its pre-filming condition as soon as possible. Failure to do so may result in loss of damage deposit.

The Applicant acting through its authorized agent, agrees to defend, protect, indemnify and hold Eagle Mountain City harmless from any from any and all suits, claims, damages, liabilities, or losses, including attorney fees and costs, for injury to or death of any person(s) or for damage to any property arising from the Applicant's acts or omissions under the film/photography permit, or resulting from the filming/photography to be held on the locations, times and dates (Premises) named in the film permit.
